2024 Indiana Stock Show Exhibitors,

This letter is to answer some of the most asked questions and help make your trip to Cloverdale a little smoother. This is also a reminder of the consequences of a failed drug test & a list of approved medications.

We want exhibitors to be able to practice the best animal husbandry possible & treat their animals. The top 5 animals (or any number selected by the ISS committee & random animals) in each species will be tested via urine or blood sample. If any other substance other than the medications listed is found in the urine or blood sample collected from those animals, then the following consequences will occur for that individual exhibitor:

- a. Disqualified from exhibiting at the Indiana Stock Show for two years.
- b. Ineligible for any & all scholarships given by the Indiana Stock Show.
- c. Any & all premium money will be forfeited.
- d. All banners & awards will go back into the possession of the Indiana Stock Show after pictures are taken and returned to exhibitor after a passed drug test. If drug test is failed, then the awards will not be returned.
- e. If awards are not returned to Indiana Stock Show staff after pictures are taken, then you will be billed at ISS discretion and disqualified from showing for 1 year.
- f. If an exhibitor returns to show at Indiana Stock Show and has an animal fail a drug test for a second time the result will be permanently disqualified from showing at the Indiana Stock Show.

The list of approved medications is as follows: Banamine, Dexamethasone, PreDef 2x, Salix, BO-SE, MU-SE, Baytril, Draxxin, LA-200, NuFlor, Micotel, Naxcel, Excenel, Excede, Penicillin, Phos-Aid, Polyflex, & Altrenogest.

→Things to know:

General Information

- **NEW FOR 2024:** A top 3 in each breed/division will still be selected **HOWEVER**, only the Champion & Reserve will be eligible for Top 5 Overall Honors.
- **NEW FOR 2024:** Cattle Stalls will be assigned. See below for more information.
- **Exhibitors must show their own animals in showmanship. No exceptions. An exhibitor cannot show a sibling's animal or any other animal other than one that is entered & will be shown by them in the show.**
- Entries are closed.
- Exhibitors cannot have helpers in the ring. Must show animals on their own, with the exception of the breeding ewe show. If there is a special circumstance please talk with Amanda prior to show.
- The flooring where all animals will be penned/stalled is covered in rubber mats.
- **NO SHOWING/FITTING OFF OF TRAILERS.** All trailers are to be parked down the road from C Bar C. Signs will be posted.

- We will assign pens/stalls upon arrival. If you wish to pen or stall with someone please intend to arrive together.
- *Generators are welcomed & encouraged!!! Must be placed outside of the building when running.*
- Animals can arrive Thursday, Aug. 29 from 9 am – 9 pm. Barn will open at 9 am. Not sooner. Must be on the grounds by 9 pm. C Bar C Expo Center address: 253 Stardust Rd; Cloverdale, IN 46120
- The Grand Drives will be Sunday at approximately 2 hours after the last ring has completed its show. This will be for breeding females & market animals. Order will be determined & announced Saturday.
- Once you are done showing you are free to go. If your animal is Champion or Reserve in a breed or division you must stay for Grand Drive. Any Exhibitor and family that has a Champion or Res. Breed/division winner that does not stay for the Grand Drive will be disqualified for 1 year from exhibiting at Indiana Stock Show.
- If an exhibitor wants to pick their own pig pens, lamb or goat stalls you have the option to come help set pens up, however you may only save pens for yourself, not a bunch of your friends. Contact Amanda to get more details. **Watch Facebook & Snap Chat for details on pen set up!**
 - *Pigs, sheep, & goat exhibitors who participate in setting up pens may bring tack/bedding etc. to get your pens starting Wednesday the 28th at 12pm – 7 pm. (End time subject to change.)*
- There will be scales available to weigh animals.
- No health papers required.
- *Check In & weights*
 - Upon arrival at C BAR C, please make your way to the show office to sign the drug test consent form, get your exhibitor number, & this is when you will be able to substitute entries. For example, you entered 2 market lambs & 2 breeding ewes. But you decided to bring 4 market lambs. Then we will change that for you in the office. REMEMBER you can only substitute not add any entries at this point.
- For all camping reservations and/or questions call or text Steve at C Bar C at 765-720-3251
- Each exhibitor will need to fill out an Exhibitor Consent Form. It will be posted on the website to print off and there will be copies available at the show.
 - If you are sending a minor exhibitor to the show with friends or a family member, then you MUST fill out & sign the form prior. Exhibitors will not receive their exhibitor numbers without the form properly filled out & they will not show without their exhibitor number.
- Shavings will be available for purchase.

Cattle

- **NEW THIS YEAR: CATTLE STALLS WILL BE ASSIGNED.** Cattle exhibitors must turn in the total number of calves they are bringing to Amanda by Monday, August 26 at 12 noon via email.
 - Email exhibitor name & total number of calves bringing to info@indianastockshow.com.
Email subject: CATTLE STALLS.
 - If you do not bring the number of cattle you say you are bringing and take more stall space than needed we reserve the right to take that space away to make room for other exhibitors.
- Mulch will be provided for cattle stalls on a first come first served basis.
- There will be shavings available for purchase.
- Wednesday, the 28th at 12 noon the barn will be open to set up cattle stalls ONLY.
- Cattle exhibitors need to bring their own bedding for tie outs. Tie outs are outside in the outdoor arena which is fenced in completely.

Pigs

- NO EAR TAGS FOR PIGS. Will be using ear notches for ID purposes. You may leave or take out any other ear tags.
- Market hogs & breeding gilts: 1 pig per pen, prospects: 2 per pen! Siblings/family members will need to combine prospects. If a brother & sister each bring a prospect, then those 2 pigs will share a pen. Bring divider gates for pens.
- NO TACK PENS until after 9 pm on Thursday or after all pigs are penned. Show committee will remove your tack from any pens if used for tack before all pigs are penned.

Sheep & Goats

- HORSE STALLS WILL BE USED FOR SHEEP & GOAT PENS.
- Sheep & goat exhibitors will get 1 stall each EXCEPT for those exhibitors showing sheep AND goats. They will get one stall per 4 animals. Example an exhibitor brings 3 sheep & 1 goat that = 1 stall. If a family brings a total of 5 sheep & 3 goats that = 2 stalls.
- If you want to split your stall, then you are responsible for bringing your own gates to do so.
- Horse stall dimensions are 10' X 10'.
- NO TACK STALLS! (Any open stalls after all animals are in Thursday night are up for grabs.) Bring tents to set up outside the barn. **Please see rules on tent guidelines.**
